Pursuant to RSA 230:45, attached hereto is a Petition for a hearing on the proposed reconstruction and realignment of a 1.3-mile portion of NH Route 16 in the Towns of Dummer, Cambridge and Errol.

The Petition is for control of access and the Department of Transportation requests that a Special Committee be appointed by the Governor, with the advice of the Executive Council, to hold a hearing to determine whether there is occasion for the laying out or alteration of NH Route 16, as described above and name Councilor Michael J. Cryans as the Committee Chairperson. The Special Committee shall determine whether there is occasion for the proposed reconstruction as presented at the hearing.


To His Excellency, the Governor, and the Honorable Executive Council:

I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, in accordance with RSA 230:45, propose realigning and reconstructing a 1.3-mile portion of NH Route 16 in the Towns of Dummer, Cambridge and Errol, at the location described below.

**Dummer-Cambridge-Errol, X-A004(699), 16304B,**

This project will make improvements to NH Route 16, which runs adjacent to the Androscoggin River. The project will begin near the Dummer-Cambridge town line and will extend northerly towards Errol for approximately 1.3 miles. The improvements will realign and reconstruct this segment of NH Route 16 to enhance mobility along the corridor. This project will affect municipal property and property owned by the Land and Community Heritage Investment Program (LCHIP).

Therefore, I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, in accordance with RSA 230:45, propose realigning and reconstructing a 1.3-mile portion of NH Route 16 in the Towns of Dummer, Cambridge and Errol.
