REQUESTED ACTION

Authorize New Hampshire Department of Agriculture, Markets & Food, Division Agricultural Development (DAMF) to amend a Cooperative Project Agreement (MOU) with the University of New Hampshire ("Grantee") VC #315187 for the State of New Hampshire Farm and Ranch Stress Assistance Network (FRSAN)-Collaborating to Address and Reduce Farmer Mental Health and Stress, by extending the completion date from August 31, 2022 to August 31, 2023 effective upon Governor and Council Approval. No additional funding is involved in this time extension. The original grant was approved by the Governor and Council on October 27, 2021, item #47.

EXPLANATION

The New Hampshire Department of Agriculture, Markets & Food, Division Agricultural Development (DAMF) has an active Cooperative Project Agreement (MOU) with the University of New Hampshire to address some primary root causes of farmer stress, mental health, and suicide. NH FRSAN project consists of five organizations who collaboratively developed the program and these groups will work with additional organizations and vendors who will provide services to NH farmers. The main program topics are 1) Building awareness and destigmatizing farmer mental health, 2) Education for farmers and agricultural service providers, 3) Farmer wellness and support, and 4) Developing resource libraries.

On-line and in-person events, podcasts, videos, print materials and counseling opportunities will address major drivers of farmer stress including farm family dynamics, farm labor, crisis management, farm financial, legal, conflict management, and stress management.

This extension request, which has been approved by the USDA, the grantor, will allow the parties more time to set up the program resources and to conduct appropriate outreach to the farm community as well as service providers.

3. Continuance of Agreement: Except as specifically amended and modified by the terms and conditions of this Amendment, the Agreement, and the obligations of the parties thereunder, shall remain in full force and effect in accordance with the terms and conditions set forth therein.



COOPERATIVE PROJECT AGREEMENT

between the
STATE OF NEW HAMPSHIRE, **DEPARTMENT OF AGRICULTURE, MARKETS AND FOOD**
and the
University of New Hampshire of the UNIVERSITY SYSTEM OF NEW HAMPSHIRE

- A. This Cooperative Project Agreement (hereinafter "Project Agreement") is entered into by the State of New Hampshire, **Department of Agriculture, Markets and Food**, (hereinafter "State"), and the University System of New Hampshire, acting through **University of New Hampshire**, (hereinafter "Campus"), for the purpose of undertaking a project of mutual interest. This Cooperative Project shall be carried out under the terms and conditions of the Master Agreement for Cooperative Projects between the State of New Hampshire and the University System of New Hampshire dated November 13, 2002, except as may be modified herein.
- B. This Project Agreement and all obligations of the parties hereunder shall become effective on the date the Governor and Executive Council of the State of New Hampshire approve this Project Agreement ("Effective date") and shall end on 8/3/22. If the provision of services by Campus precedes the Effective date, all services performed by Campus shall be performed at the sole risk of Campus and in the event that this Project Agreement does not become effective, State shall be under no obligation to pay Campus for costs incurred or services performed; however, if this Project Agreement becomes effective, all costs incurred prior to the Effective date that would otherwise be allowable shall be paid under the terms of this Project Agreement.
- C. The work to be performed under the terms of this Project Agreement is described in the proposal identified below and attached to this document as Exhibit A, the content of which is incorporated herein as a part of this Project Agreement.

- A. **Project Title:** State of NH Farm and Ranch Stress Assistance Network-Collaborating to Address and Reduce Farmer Mental Health and Stress
- B. **Project Period:** 09/01/2021 - 08/31/22
- C. **Objectives:** Our New Hampshire FRSAN project is exemplified by collaboration between agricultural organizations and agencies to address some primary root causes of farmer stress, mental health, and suicide. Five organizations collaboratively developed this program, with seven additional agricultural organizations participating, as well as vendors who will provide services to NH farmers. The Co-PDs and program coordinator will oversee the implementation of our four program branches: 1) Building awareness and destigmatizing farmer mental health, 2) Education for farmers and agricultural service providers, 3) Farmer wellness and support, and 4) Developing resource libraries. Social Media, local and regional print media, local radio, and direct farmer outreach will provide information to the agricultural community about mental health and will educate this community about how farmers can access the resources available through this project. Special efforts will be made to reach BIPOC and LGBTQ+ communities. Multi-modal educational outputs will build skills for farmers and agricultural service providers. On-line and in-person events, podcasts, videos, and print materials will address major drivers of farmer stress including farm family dynamics, farm labor, crisis management, farm financial, legal, conflict management, and stress management. Mental health, legal, financial, and credit counseling services will be accessible through registered vendors. Farmer-to-farmer support groups will provide support addressing root cause issues around mental health and stress. Resource libraries consisting of information developed through this project, as well as existing resources, will be housed on websites of NH Department of Agriculture, UNH Cooperative Extension and NH Farm Bureau.
