#### **REQUESTED ACTION**

That approval be and hereby is given to the Attorney General to reappoint Laura E. Lombardi (position #9U048, appropriation #02-20-20-201010-2620-013-500132) as an Assistant Attorney General at a salary level of \$91,737.50. Ms. Lombardi will be occupying a position for a five-year term, effective upon Governor and Executive Council approval through July 31, 2023.

#### EXPLANATION

Ms. Lombardi is a resident of Concord and a member of the New Hampshire Bar. She is a 1997 graduate of the University of Maine, School of Law and received a B.A. from Bates College in 1994. She was a Law Clerk for the New Hampshire Superior Court and the Maine Supreme Judicial Court prior to joining the New Hampshire Department of Justice, Civil Bureau in August 2001. Ms. Lombardi began her career with the Department on August 30, 2001, working in both the Civil and Criminal Bureaus as an appellate attorney. She was appointed as an Assistant Attorney General in August of 2002, and promoted to the position of Chief of the Civil Appellate Unit in 2014. Her salary of \$91,737.50 will remain the same. A copy of her resume is attached.

2001 Laws of NH Chapter 158 amended RSA 94:1-a(I)(c)(3) to provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
