#### REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Shane B. Goudas as an Assistant Attorney General to Position #9U615 (Appropriation #02-20-20-200510-29040000-013-500132) at a salary level of \$74,896.24, effective upon Governor and Executive Council approval.

#### **EXPLANATION**

Mr. Goudas is a resident of Manchester and a member of the New Hampshire Bar. He received his undergraduate degree, *cum laude*, from the University of New Hampshire, Whittemore School of Business and Economics, in 2014. He earned his Juris Doctor, *magna cum laude*, from Suffolk University Law School, in 2017. While in law school, he interned at the Boston Municipal Court in 2015 and was certified as a Student Prosecutor for the Suffolk County District Attorney's Office. He was a member, and Captain, of the Constitutional Law Team, a Dean's List Scholar, and a three-year recipient of the full-tuition, merit-based Sargent Scholarship. After graduating from law school, Mr. Goudas prosecuted criminal cases as an Assistant District Attorney for the Middlesex County District Attorney's Office from September 2017 to December 2018, when he began work as an Unemployment Fraud Prosecutor for the New Hampshire Department of Employment Security. Mr. Goudas joined the Department of Justice in August 2019, where he has been assigned to the Drug Prosecution Unit. His salary will increase by \$3,000, from \$71,896.24 to \$74,896.24. I plan to continue his current assignment. A copy of his resume is attached.
