For the consideration on the consent calendar, pursuant to NH RSA 4:8, Gifts to the State, authorize the New Hampshire Hospital to accept donations from October 1, 2017 through December 31, 2017, from contributors as per the attached list in the amount of \$2,110.91 and deposit same into the New Hampshire Hospital Resident Benefit Fund.

EXPLANATION
