**EXECUTIVE ORDER 2011-7**

**An Order Continuing Certain Boards and Commissions**

**WHEREAS**, the legislature in 2009 Laws Chapter 144: 87 I, (c) provided for the sun-setting of all boards, commissions, councils, advisory committees and task forces that were created by an executive branch department, agency, administratively attached agency or executive order, unless extended and reinstated by the Governor; and

**WHEREAS**, there are boards and commissions, councils, advisory committees and task forces that are established in accordance with federal law or which the governor has otherwise determined to continue;

**NOW, THEREFORE, I, JOHN H. LYNCH**, Governor of the State of New Hampshire, by virtue of the power and authority vested in me by Part II, Articles 41 of the New Hampshire Constitution, do hereby order, effective immediately, as follows:


