Authorize the Department of Health and Human Services, to enter into an educational tuition agreement and to pay said costs in an amount of \$2,189.60 as follows:

EXPLANATION

These courses, Social Stratification and Inequality and Integrative Capstone: Project in Human Services, will benefit Ms. Farwell and the Department as they are part of the Bachelor's in Psychology with a concentration in Human Services degree that Ms. Farwell is pursuing. Social Stratification and Inequality explores the diversity of life experiences in contemporary America and assesses structured inequality in terms of socioeconomic, racial, gender, and sexuality differences. Using the theoretical framework of the social construction of race, gender, economic class, sexual orientation, and disability in historical contexts, the course examines how and why stratification systems emerge and are reproduced. Alternatives to the categories of difference and the processes, philosophical developments, institutions, and conditions that lead to and rely on power and privilege in modern society will be considered. Integrative Capstone: Project in Human Services is a project based course that focuses on the concepts and techniques of successful Human Services practitioners. Ms. Farwell will integrate the knowledge and skills gained from other courses in the Human Services program and demonstrate her ability to apply knowledge to new subject matter and practical situations. She will develop and implement a project within her chosen concentration (professional interest) that includes an applied research project, a written rationale, and synthesis of theory and practice. These courses will strengthen Ms. Farwell's administration skills and build upon her knowledge of management practices, thereby enhancing her ability to understand staff behaviors and how to build a cohesive team.

Jody Farwell is currently an Administrator I for the Division of Medicaid Services. She has been employed by DHHS for fourteen (14) years. As a Division of Medicaid Services Administrator, Jody is responsible for the planning, coordinating and development of program objectives and policies, CMS rules and fiscal impact statements, forms, instructions and procedures used by staff in twenty-four (24) local offices to implement all programs offered by the Division of Medicaid Services.

The Department of Health and Human Services encourages and supports employees who wish to further their professional growth through continuing education in disciplines that are mutually advantageous. Successful completion of the program will also add to the overall strength of the Department to perform its mission to the residents of New Hampshire.

This course will not be taken on State time.

THE STATE OF NEW HAMPSHIRE
EDUCATIONAL TUITION AGREEMENT

Agreement dated this 16th day of August, 2022 by and through the Department of Health and Human Services (hereinafter referred to as the "State") and Jody Farwell (hereinafter referred to as the "Recipient"). The State and the Recipient do hereby mutually agree as follows:

1. The State shall pay to the named institution the sum of \$2,189.60, which monies shall be used for the purpose of enrolling the Recipient in: Social Stratification and Inequality and Integrative Capstone: Project in Human Services, which are course(s) being offered by Granite State College and which course(s) shall commence on September 19, 2022 and terminate on March 24, 2023.
2. The Recipient shall complete and achieve a passing grade in each course named in paragraph 1.
3. Should the Recipient fail to complete or achieve a passing grade in each course named in paragraph 1, the Recipient shall pay to the State the sum set forth in paragraph 1, provided, however, that if more than one course is named in paragraph 1, the amount which shall be paid to the State shall be calculated on a pro rata basis.
4. Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of six (6) months.
5. The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.
6. Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.
7. The Recipient shall not raise any setoff or counterclaim against the State in any action brought by the State to collect any amount due under this agreement.
8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
