REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Weaver Bros. Construction Co., Inc. (Vendor 154074) of Bow, NH on the basis of a low bid of \$669,520.25 for replacing a deteriorated 9' by 5' reinforced concrete box culvert carrying NH Route 11A over West Alton Brook in Gilford, from the date of Governor and Council approval through November 17, 2017 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

2. Further authorize that a contingency in the amount of \$33,476.01 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Plan under the Culvert Replacement Program and will replace the existing concrete box culvert carrying NH Route 11A over West Alton Brook. The project site is located just west of the Alton/Gilford Town line. The work involves a temporary road closure for box culvert installation, minor profile adjustment and step box widening of NH 11A, and bridge rail replacement.

This project will replace a 1930's era 9' wide x 5' high concrete box culvert in poor condition with a16' wide x 8' high reinforced concrete box culvert. The new bridge will meet hydraulic, aquatic organism, and wildlife passage requirements, and provide improved stream alignment. The new 32' roadway typical will provide additional width for plowing/pedestrian/biking needs, and new guardrail meeting current standards.

The contingency amount is proposed to be 5% of the contract amount. The contingency proposed is due to the potential for higher than anticipated boulder quantities in the excavation items and the overall excavation limits, including the excavation for the box culvert, the channel excavation, and the temporary diversion structure.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project will replace a deteriorated 9' by 5' reinforced concrete box culvert carrying NH Route 11A over West Alton Brook, with an embedded 16' by 8' reinforced concrete box culvert. The project site is located just west of the Alton/Gilford Town line. The work involves a temporary road closure for box culvert installation, minor profile adjustment and step box widening of NH 11A, and bridge rail replacement.

FEDERAL FUNDING: 80% Federal, 20% State Turnpike Toll Credits.

CONTINGENCY: The contingency amount is proposed to be 5% of the contract amount. The contingency proposed is due to the potential for higher than anticipated boulder quantities in the excavation items and the overall excavation limits, including the excavation for the box culvert, the channel excavation, and the temporary diversion structure.


PROJECT INITIATED: State Ten Year Plan – Culvert Replacement Program

PROJECT EXPLANATION: This project will replace a 1930's era 9' wide x 5' high concrete box culvert in poor condition. The new bridge box culvert will meet hydraulic, aquatic organism, and wildlife passage requirements, and provide improved stream alignment. The new 32' roadway typical will provide additional width for plowing/pedestrian/biking needs, and new guardrail meeting current standards.

TRAFFIC IMPLICATION: NH 11A will be closed for period of up to 19 calendar days during the period of September 5, 2017 through September 29, 2017, not to exceed two weekends, to install the culvert, selects, binder, and guardrail. Message board signs and a signed detour will direct traffic around the site during the closure period, and bus transportation will be provided for the one residential property affected by the closure. The month of September was selected for the closure due to a decrease in monthly traffic volumes and anticipated low stream flow during this time period.


