REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH on the basis of a low bid of \$4,989,628.08 for 33 miles of pavement resurfacing with six sections in the central and southwestern portion of the State, from the date of Governor and Council approval through September 13, 2019 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan under the Tier 2 Pavement Resurfacing Program (Pave-T2-Resurfacing). This project is part of the CY 2019 Tier 2 Preservation program and involves 33 miles of pavement resurfacing with six sections in the central and southwestern portion of the state.

Additional work involves cable guardrail replacement and a pavement marking realignment in Plymouth.

This project is part of the annual Federal Resurfacing Program. The preservation sections will extend the life of the existing roadway and maintain it in good condition. Minor rehabilitation sections will repair current pavement distresses and return the roadways to a good condition. The light capital paving section will extend the life of the existing roadway eliminating the need for more costly improvements in the near future. Cable guardrail will be upgraded to current standards.

The proposed contingency amount is 5% of the contract amount. The project was not surveyed and therefore, items have been quantified based on field observations, as-built plans, and aerial photos. Field adjustments may be required due to varying conditions and asphalt prices are currently in escalation.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.




TRAFFIC IMPLICATION: Traffic impacts are expected to be minimal and will likely consist of minor delays due to congestion and minor disruption at intersections. Traffic control measures will likely include lane shifts, lane closures (areas with multiple directional lanes only), and one-way, alternating two-way traffic as appropriate. Traffic control will be supplemented with flagger and uniformed officers. To mitigate disruption, work a portion of the Plymouth section and all of Milford section will be scheduled during night-time non-peak hours.


41614 - ALL LOCATIONS
