

BPG partnered with Seiberlich Trane Energy Services to modernize the facility's infrastructure and improve tenant comfort. The project leveraged Commercial Property Assessed Clean Energy (C-PACE) financing, the first project to do so in the state of Delaware. The tour is limited to the first 35 full conference registrations.
