1). Authorize the Division of Public Works Design and Construction to enter into a contract with Careno Construction Co., LLC., (VC# 159063) Portsmouth, NH, for a total price not to exceed \$998,400, for the Jenness Bathhouse Replacement and Parking Lot Improvements, Rye, NH. This contract is effective upon Governor and Council approval through May 22, 2019, unless extended in accordance with the contract terms. **51% General – Capital Funds, 49% Other Funds.** 

2). Further authorize that a contingency in the amount of \$150,000 be approved for unanticipated expense for the Jenness Bathhouse Replacement and Parking Lot Improvements, bringing the total to \$1,148,400. **69.55% General Funds, 30.45% Other Funds.** 

3). Further authorize the amount of \$45,000 be approved for payment to the Department of Administrative Services, Division of Public Works Design and Construction (VC# 177875), for engineering services provided, bringing the total to \$1,193,400. **79% General – Capital Funds. 21% Other Funds.** 

4). Further authorize, pursuant to RSA 19-A:9, II, the transfer of \$5,000 to the State Art Fund, within the Department of Natural and Cultural Resources. This transfer is for the purchase of art for the Jenness Bathhouse, Rye, NH. Appropriation Number 01-035-035-353510-41000000-406342. **100% General - Capital Funds**

### **EXPLANATION**

Per Chapter 228:15, XI, Laws of 2017 for the Jenness Bath House and Chapter 228:1, XVIII, G, Laws of 2017, for the Jenness Beach Bath House Replacement and Parking Lot Redevelopment. This project will demolish the existing bathhouse and construct a new bathhouse including men's room, women's room, family toilet room, mechanical room, plumbing chase, exterior showers and changing stalls. We will reconstruct a wider parking lot with improved storm water drainage, repaying and restriping per plans and specifications.

The contractor has been pre-qualified by the Department of Transportation. The contract has been approved by the Department of Justice as to form and execution, and the Department of Natural and Cultural Resources has certified that the necessary funds are available. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Services, Division of Public Works Design and Construction.

- PROJECT: DPW Project No. 80877, Contract C Jenness Bathhouse Replacement and Parking Lot Improvements REBID, Rye, New Hampshire.
- DESCRIPTION: Demolish the existing bathhouse and construct a new bathhouse including men's room, women's room, family toilet room, mechanical room, plumbing chase, exterior showers and changing stalls. Reconstruct a wider parking lot with improved storm water drainage, repaving and restriping per plans and specifications.
- EXPLANATION: The existing bathhouse at Jenness State Beach is outdated, undersized and overused by its patrons. By replacing the bathhouse with the proposed building, we are adding more fixtures and room for storage of maintenance items. We're also adding a family toilet room, baby changing tables, outdoor changing stalls, access ramp, and ADA compliant men's and women's rooms. The parking lot will have increased site lighting and reconfigured parking spaces to improve traffic flow through the site.

The estimate DPW received from the consultant contained lower prices than the bidders submitted. Project location, winter construction, and a very restricted project site all contribute to the high cost of the low bidder.
